# NRA

My fellow NRA Member:

Since the NRA was founded almost 150 years ago, our adversaries have repeatedly tried to take us down. Today is no different. A recent burst of media claims the NRA is vulnerable, financially unstable, and weakened in its fight to defend the Second Amendment. Obviously intent on not letting the facts get in the way of a good story, most reports offer a distorted and inaccurate view of the NRA. As officers and past presidents of the NRA, we write today to set the record straight.

As you may know, we recently convened in Indianapolis for one of the largest NRA conventions in our history. More than 80,000 of our members showed up to gather as one NRA family – to support our Association and celebrate our nation's constitutional freedoms. During our annual Members Meeting on April 27, some asked for greater insight into three issues: the NRA's financial affairs, our direction and strategy, and the supervisory role being played by our board of directors. We had an open forum and spirited discussion.

Of course, our discussions were portrayed as a sort of family feud. (Infighting at the NRA – Chaos and Controversy!). At the NRA, we take pride in the fact that our Association is inclusive and invites the active participation of every member. Every member has an opportunity to voice any concern they may have at the Members Meeting. In fact, our greatest privilege is hearing from our members. Like many of you, that's why we were at the Members Meeting in the first place and spent countless hours on the convention floor.

Fact: During a board of directors meeting on April 29, Wayne LaPierre was elected by acclamation to continue serving as our CEO and Executive Vice President. The board also unanimously elected Carolyn D. Meadows to serve as our new president.

Perhaps looking for a way to counter the narrative about a

stronger, more unified NRA, questions have now conveniently surfaced about our financial situation and our standing in the regulatory arena. There also have been frequent attacks on Wayne's personal character.

Fact: According to the NRA's chief financial officer, we are on budget in 2019. The NRA is meeting all banking and supplier financial obligations and we continue to aggressively manage our cost structure to offset the orchestrated and calculated attacks against NRA's finances in 2018. Put another way, our financial house is in order – we aren't going away.

We have full confidence in the NRA's accounting practices and commitment to good governance.

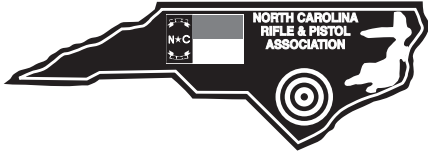
Fact: The Association's financials are audited and its tax filings are verified by one of the most reputable firms in the world. Internally, the Association has a conflict of interest policy and, where appropriate, related-party transactions are reviewed and approved by the board's Audit Committee.

wasn't as evident in this "disclosure" is that the clothing expenses referenced in media reports dated back to expenses from 15 years ago! To put it in perspective, over this time period, Wayne has participated in thousands of events and hundreds of TV appearances, and personally directed fundraising efforts that total in the hundreds of millions of dollars. In any event, this practice was discontinued some time ago.

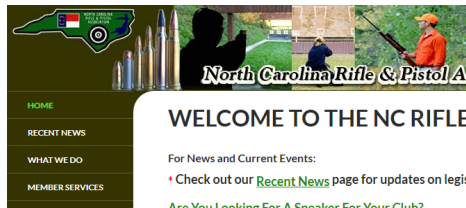
Fact: We will confront our opponents, defend our values, and proudly continue our tradition as the greatest civil rights organization in the world.

# 5 Inexpensive Ways for Rural North Carolina Landowners to Lower Their Accident Liability Risks

North Carolina landowners may worry from time to time about accident liability exposure from ranch or farm employees, hunters, fishermen, lease users (leasees) or other invited guests, or even from uninvited trespassers unknowingly using your land.

North Carolina law recognizes two classes of land users: lawful visitors and trespassers.

A landowner owes the highest legal duty to a lawful visitor. Lawful visitors access the landowner's

property with the knowledge and permission of the landowner. A landowner must exercise "reasonable care" to protect any lawful visitor from injury.

An "unlawful visitor," or trespasser, enters the premises of another without permission, or any other right to be there. The landowner owes very little legal duty to a trespasser: the law only requires that the landowner avoid any willful (intentional) injury to the trespasser.

Trespassing children, if they are entering a landowner's property to access an "attractive nuisance" such as a pond or junk pile, are owed the higher "lawful visitor" legal duty from the landowner. If the child's actions are legally found to be negligent, however, landowner liability may be reduced in some cases. Under the NC "Attractive Nuisance Doctrine" children under the age of 7 cannot be found negligent under any circumstances. Older children are held to increasing negligence standards.

A landowner may owe the higher lawful visitor legal duty if he gives "Implied permission" to use his land. A landowner may thus legally convert trespassers to higher liability lawful visitors if, for example, he does not properly post his land, or if the landowner often tolerates visitor access without the express permission of the owner.

If you are a North Carolina rural property owner, here are 5 easy and affordable and ways to help you sleep better at night:

## 1. Post Your Land, and Install Proper Gates!

To properly post your land in North Carolina, follow these rules:

- A “No Trespassing” or other similar warning or notice signs must measure not less than 200 square inches;
- Such notices, signs, or posters must be posted along land boundaries, no less than 200 yards apart, with at least one notice sign located on each side of the property boundaries;
- Each land corner must be posted;
- To prohibit fishing or any taking of fish, appropriate signs, notices, or posters may be posted along the stream, or along a pond or lake shoreline at intervals not more than 200 yards apart;
- Purple paint may be used instead of notice or warning signs, according to the following rules: see N.C. Gen. Stat. § 14-159.7.

Install easy-to-see gates, such as farm and ranch style multiple bar gates, across any private entrance to prevent unauthorized entry. Do not use cable gates, because the cables may be hard to see, particularly at night or in low light, and may inadvertently injure ATV or other vehicle occupants, horses and horse riders, or other visitors.

## 2. Eliminate Attractive Nuisances, or Fence Them Off

Clean up anything that looks hazardous, such as a sharp rusting pile of metal farm junk. If your land contains a stock pond on it, particularly if it is visible from a road or school, or children are known to frequent the area, you might need to appropriately fence off the parcel.

## 3. Use a Written Waiver of Liability and Assumption of the Risk Contract, or Lease Contract

A written contract, clearly explaining inherent risks on the property, and having guests assume the risks of any hazardous activities they may voluntarily participate in, can help reduce the chance of a successful legal award if an accident occurs. All leases should be governed by a written contract, which clearly points out hazards, and has the lessee assume the risk of any hazardous activities (like hunting) that he voluntarily participates in.

If you are handing out waivers and assumption of the risk contracts to a Boy or Girl Scout troop before they camp on your property, make sure that parents

or legal guardians sign for any visitor under age 18, as minors cannot legally form a contract in NC.

## 4. Put Your Land In an LLC

With the right legal assistance, it is normally affordable and fairly easy to place your rural property into an LLC (Limited Liability Company.) I like LLCs because they are relatively inexpensive to maintain and easy to administer, with no required annual meetings.

An LLC may provide a rural landowner with an accident “liability cap,” so that if a visitor has an accident on the landowner’s property producing legal liability, the landowner’s other personal assets are normally protected from lawsuit risk.

Placing rural property into other types of corporate structures such as a corporation or limited partnership may also protect the landowner’s other assets against accidents on the rural property.

## 5. Purchase Liability Insurance

Even if you have placed your rural property into an LLC, property liability insurance can protect the value of your rural parcel itself. And property liability insurance policy should be considered on any rural land where third parties will be legally accessing your property.

# First Civilian Team In History Takes Home Gold Cup At National Trophy Pistol Matches

CAMP PERRY, Ohio – “Civilian teams are not supposed to win the Gold Cup,” said Christopher “Neil” Roberts, smiling and having lighthearted conversation with the other members of his North Carolina Rifle and Pistol Association team – all still in shock at what they had just accomplished earlier that day.

He was referring to the award given to the Overall Scoring team in the National Trophy Team (NTT) Match fired during the Civilian Marksmanship Program’s (CMP) 2019 National Trophy Pistol Matches. The NTT is a prestigious event, won every year since 1920 by skillful military teams – that is, until this year.

Breaking the near 100-year history of the event, Roberts, along with teammates Cecil Rhodes, Jon Shue and Tom Willats, claimed the overall spot and the accompanying Gold Cup after outshooting both civilian and military assembled teams, with a combined score of 1109-30x.

“It was shocking,” said Willats, 56, of Raleigh. “It was really exciting.”

It was only just prior to the National Matches that they had discussed putting together a team for Camp Perry. The men have been acquainted with each other through competition for years, especially from the Eastern CMP Travel Games held annually at Camp Butner in North Carolina, where Shue and Willats have won the Pistol Team Match together in the past.

Regulars at the National Matches for over 20 years now, the men thought it would be fun to assemble a North Carolina team to fire in the NTT Match – and the melded chemistry of the group turned out to be more powerful than they had realized.

“We weren’t even sure who was going to be shooting until we were starting the match,” Roberts, 46, of Charlotte, joked. “But it worked out.”

It was his first time shooting the pistol team match at Camp Perry, serving as the “new shooter” (that is, new to the match) that is required for the NTT. Finally set with their team, the crew came into the match with only a goal of beating the other state association team, certainly not the mindset of taking home the ultimate prize.

The team from North Carolina was filled with talented Distinguished marksmen.

“We were hoping to win the civilian part, the Oglethorpe Cup, then as we got to talking, we thought, ‘We might be in this thing...’” Roberts explained with a hearty laugh.

And, of course they were in it. The team had the talent, with all four members having earned Distinguished Service Pistol Badges years ago and having marksmen who had competed in the NTT before, aware of its unique challenges.

Rhodes, 62, of Clayton, who has been coming to Camp Perry for the last 22 years, had only fired in the team match once before and was let down by its outcome. This year, he picked the right time to try it again and credits his team for giving him a second chance.

“These guys carried me all the way. It was actually my worst match of the day, but these guys shot so well that it actually pushed us over the top, so it was really great,” he said with a smile. “I’m grateful to Jon for letting me shoot again. I had fun.”

Having now reminded the competitive shooting community that anything really is possible on the sacred grounds of Camp Perry, the guys think more civilian teams will sign up for the NTT in the future, and the men from the Tarheel State will be ready for them – already set on defending their title at next year’s event with fresh recruits in the works.
